Early voting by personal appearance will be conducted on weekdays beginning Monday, April 28, 2008, and continuing through Friday, May 2, 2008, between 8:00 a.m. and 5:00 p.m., Saturday, May 3, 2008, between 8:00 a.m. and 5:00 p.m., Sunday, May 4, 2008, between 1:00 p.m. and 6:00 p.m., and Monday, May 5, 2008, through Tuesday, May 6, 2008, between 7:00 a.m. and 7:00 p.m. Any qualified voter for the Joint Election may vote early by personal appearance at either the main early voting location or at any of the branch locations.
